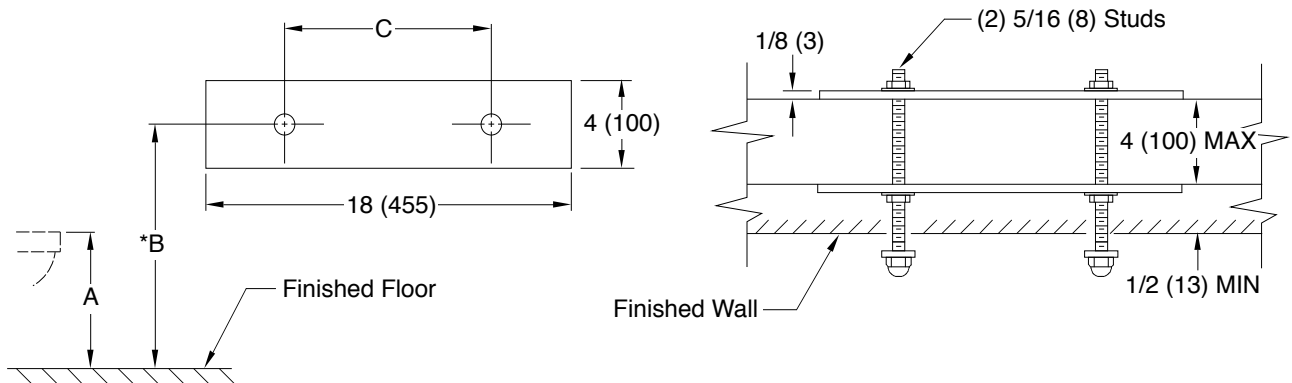


Fig. 0827 . . . FOR USE WITH STUD SUPPORTED URINALS
